DATA PROTECTION OFFICERS

The Information Commissioner organises periodic data protection workshops for Data Protection Officers (“DPOs”) in Gibraltar. These form part of his efforts to promote awareness amongst data controllers of their data protection obligations and to assist DPOs, as appropriate.



Specific topics are discussed at each workshop and guidance is provided throughout, to assist in ensuring compliance.

As well as an opportunity for data controllers to obtain further support, the workshops help create synergies by facilitating collaboration between DPOs on issues that are common to data controllers.

DPOs should have expert knowledge of data protection law and practices.

See Article 37(5) of the Gibraltar GDPR and section 78(2) of the DPA.

Participation in these workshops will likely contribute to a DPO's knowledge of data protection law.

Data controllers/processors must help DPOs in maintaining data protection knowledge.

See Article 38(2) of the Gibraltar GDPR and section 79(2) of the DPA.

Encouraging and supporting DPO attendance in these workshops helps data controllers/processors meet their data protection obligations.



Cooperating with the supervisory authority is amongst the DPO's tasks.

See Article 39(1)(d) of the Gibraltar GDPR and section 80(1)(c) of the DPA.

Participation in these workshops can be a valuable part of a DPO's cooperation with the Information Commissioner's office.
