<p><b>BN20/19</b> Royal Gibraltar Police ("RGP")</p>	<p>The investigation concerned a data breach by the RGP on 13<sup>th</sup> December 2019 regarding –</p> <ul style="list-style-type: none"><li>(a) the unlawful disclosure by the RGP of personal data contained within a case docket.</li></ul> <p>Sections breached: Sections 44(1), 49, 65(1), 65(2), 65(3), 75, 77(2) and 76(4) of the DPA.</p> <p><b>The Commissioner issued the RGP with a <a href="#">Notice of Intent to issue a monetary penalty</a>, as well as a <a href="#">monetary penalty of £5,000</a> on 6<sup>th</sup> August 2020.</b></p>
<p><b>BN23/19</b> Royal Gibraltar Police ("RGP")</p>	<p>The investigation concerned a data breach by the RGP on 10<sup>th</sup> February 2020 regarding –</p> <ul style="list-style-type: none"><li>(a) the loss of personal data as contained within two USB flash drives processed by the RGP.</li></ul> <p>Sections breached: Sections 49, 65(1), 65(2), 65(3), 75 and 77(2) of the DPA.</p> <p><b>The Commissioner issued the RGP with a <a href="#">Reprimand</a> on 7<sup>th</sup> March 2022.</b></p>
